## Short Maturity Fixed Income Composite Annual Summary

*Description: This composite includes all discretionary short maturity fixed income accounts measured against the Bloomberg Barclays 1-3 Year Government Index and the Bloomberg Barclays 1-3 Year Government/Credit Index, which were administered and supplied by Lehman Brothers prior to 11/3/08. The composite may be compared to other appropriate indices, as requested. BHMS utilizes a bottom-up security selection process, based on fundamental research, which seeks to achieve returns that are superior to the returns of its benchmarks over complete market cycles, with lower volatility of return.*

- BHMS is an investment advisor registered with the SEC. BHMS is a subsidiary of BrightSphere Investment Group Inc. ("BSIG"), a publicly-held company traded on the New York Stock Exchange. - This composite was created on January 1, 1984. The composite inception date is January 1, 1984.
- Performance is expressed in U.S. Currency. The returns include the reinvestment of all income. Gross-of-fees performance results are presented before investment management fees and custodial fees. Net-of-fees performance returns are calculated by deducting the actual fees from the accounts. BHMS Short Maturity Fixed Income Fee Schedule: 0.25% on first \$40 million; 0.15% on next \$40 million; 0.10% on assets over \$80 million. Actual investment advisory fees incurred by clients may vary.
- Dispersion of annual returns is calculated for the accounts in the composite for the entire year by an asset-weighted standard deviation calculation method beginning with 2001. Prior to 2001, an equal-weighted standard deviation calculation method was used. Where composite dispersion is N.A., the information is not statistically meaningful due to an insufficient number of portfolios for the entire year.
- BHMS has added portfolio managers and analysts to support and enhance its research capabilities and asset growth. However, no alterations of composites, as presented herein, have occurred due to changes in personnel. Past performance is not indicative of future results.
- The composite's name was changed to "Short Maturity Fixed Income Composite" from "Defensive Fixed Income Composite" in 3Q09 to reflect the industry's description of this strategy.
